




# YEAR IN REVIEW

2017 was a successful and productive year for the Australian ORCID Consortium operated by Australian Access Federation Inc (AAF).

With 27 integrations completed and another eight in the planning phase, Australian members were actively engaged throughout the year in integrating ORCID with their systems.



In 2017 the Australian Consortium continued to receive positive feedback from ORCID in relation to the consortium structure, operational model and the work that the Consortium Lead undertakes to advance ORCID within Australia for its members.

ORCID have also identified the Australian ORCID Consortium model as a leading international example and identified lessons that other consortia could learn from the Consortium's accomplishments.

The Australian Consortium membership is made up of 40 members from 36 higher education institutes, two funding bodies (ARC and NHMRC) and two research organisations (CSIRO and Heart Research Institute).

The Australian ORCID Consortium Lead (the AAF) would like to thank the ORCID Advisory Group and ORCID Governance Committee for their ongoing support in 2017.

#### **SURVEY RESULTS**

In 2017, the Consortium conducted the second annual ORCID survey. It was targeted at members to measure the support and resources provided by the Consortium Lead and obtain feedback regarding the services offered. The overall feedback indicated that members were satisfied with the services being delivered by the Consortium and the high level of support services that were available.

The key recommendations included:

- Engagement and communication: continue to develop and share communication and outreach resources
- Resources: develop integration use cases and maintain online resources
- Support and training: continue to provide individual consultations and training.

## **COMMUNITY ENGAGEMENT AND** COMMUNICATION

The Australian ORCID Consortium has been instrumental in developing and sharing communication and outreach resources with the member community. The Consortium Lead was also part of an international ORCID working group that provided input and feedback into the creation of a range of outreach resources. Since the commencement of the Consortium, the AAF has continued to develop a range of resources to assist members with communication and engagement with researchers.

#### **COMMUNITY FORUM**

The Consortium Lead in collaboration with ORCID launched the Community Forum in February 2017. The forum is an opportunity for members to engage with one another, make suggestions, provide feedback and also communicate with the Consortium Lead in a community environment. With 40 members registered as part of the Forum, the AAF will be working to encourage additional membership and interaction in 2018.

#### **DIGITAL ASSETS**

The ORCID Consortium Lead produced two digital assets, one detailing the ORCID Collect and Connect program, the other an educative and promotional video outlining the value of being part of the Australian ORCID Consortium.

Both videos have been shared on AAF's YouTube channel, newsletters and website.

#### **COMMUNICATIONS SUITE**

A suite of communication examples was also created as a resource for Consortium members to use when communicating the benefits of ORCID with researchers and staff. This suite included newsletter items, emails, website content, infographics and user guides.







In 2017, the Consortium Lead attended six conferences, both national and international, to represent the Australian ORCID Consortium. The AAF presented at five of these events and also hosted a number of conference booths.
