What is ORCID?

ORCID is a unique digital identifier (ORCID ID) which you can link your research outputs and activities to. You own your ORCID ID and it follows you through your career.

The ORCID ID is rapidly becoming an international standard which is being requested by publishers and funders to save you time and effort when publishing papers or applying for grants.

Why do you need ORCID?

- Stay connected with your research outputs, no matter where your career takes you
- Confidently claim your own contributions
- Stand out from others with your name
- Be discovered and boost your citation rates
- · Reduce repetitive form filling and save time
- Pick and choose who sees your record.

Create and connect your ORCID ID

Enable <ORGANISATION NAME> to collect your ID from ORCID and connect it to information about your research outputs and activities stored in your organisation's systems. Having an ORCID ID:

- distinguishes you and ensures your research outputs are correctly attributed to you
- provides a persistent identifier and will belong to you throughout your career
- is being requested by publishers and funders
- will save you time by pre-populating numerous data fields when completing grant applications etc.

When you register for an ORCID ID you can link it to your organisation who can collect your ID, and connect it to information about your research outputs and activities stored in local systems.

Even if you already have an ORCID ID, please link it to your organisation and authorise for them collection and use of your ORCID ID in your organisation's systems.

Now you have your ORCID ID, what can you do with it?

Dear Researcher,

After registering and obtaining your ORCID ID, it's time to make it work for you.

By following these three simple steps you can maximise the benefits of your ORCID.

1. Allow <ORGANISATION NAME> to verify your employment.

By allowing <ORGANISATION NAME> to access your record, we can verify and add information to your ORCID record and help you keep it up-to-date.

*This is only applicable if your organisation is asserting affiliation through an ORCID integration.

2. Enable automatic record updates when you publish.

Crossref and DataCite can be authorised to automatically update your ORCID record whenever you publish an article or dataset. Make sure you enable the automatic updates.

3. Connect your existing works, grants and profiles to your ORCID record.

Boost your academic profile and discoverability by having everything in one, portable place. Link your existing contributions, grants and profiles to your ORCID record.

The content outlines how a researcher can connect and use their ORCID ID to connect to organisation systems, published works, existing works and grant systems.

How to make your ORCID ID work for you

Follow this simple step-by-step guide to ensure your ORCID ID is working for you.

Allow < ORGANISATION NAME> to verify your employment

- 1. Use your ORCID ID when prompted in a system that you trust <SYSTEM NAME> e.g. grant application system.
- 2. Authorise <ORGANISATION NAME> to access your record when asked.
- 3. <ORGANISATION NAME> can now add your affiliated information e.g. your start date and affiliated department.
 - * <ORGANISATION NAME> will appear as the source of the information.

Enable automatic record updates when you publish works

- 1. Crossref will ask permission after a paper has been accepted in email form.
- 2. Follow the prompt to sign into your ORCID account and give permission.
- 3. Set up a DataCite profile and enable the ORCID Auto-Update function.
 You can activate DataCite's auto-update feature outside of the publication process.
 *Crossref or DataCite will appear as the source of information.

Connect existing works

- Use the ORCID Search & Link tool to import information from some of the biggest databases.
 e.g. Crossref Metadata Search, ResearcherID, and ScopusID; also from discipline
 specific databases like Europe PubMed Central and the MLA International
 Bibliography; and country and/or language-specific databases such as Airiti,
 KoreaMed, and Redalyc.
- 2. Select the Search & Link option under Add Works in the Works section of your ORCID.
- 3. Choose the database you want to connect with.
- 4. Grant permission for it to access and update your ORCID record.
- 5. Claim the publications that are yours when presented with the list and they will immediately appear in your ORCID record.
 - *The relevant database will be shown as the source.

Connect your existing grants

- 1. Use the UberResearch Search & Link tool similarly for the Search & Link tool used to connect existing works.
- 2. Click the Search & Link option in the Funding section of your record.
- 3. Select UberWizard for ORCID and authorise access.
- 4. Claim your grants when presented with the list.
 - *Source will be shown as UberResearch.

Connect existing profiles

- 1. ResearcherID, ScopusID Kudos, Loop, Mendeley and Publons have enabled you to connect information from them to your ORCID record.
- 2. When prompted in the above systems, choose the option to Link your ID to your current profile and grant permission to update your ORCID record.

You can choose to revoke an organisation's access via your <u>ORCID Account Settings</u> at any time if required.
